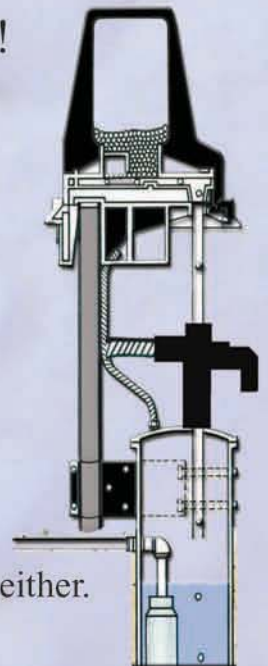

Better Water Industries, Inc. 209 North Tyler St. Tyler, MN 56178, warrants and promises that it's Sentry I Chlorinator is free of defects in materials and workmanship at the time the Sentry I leaves the factory.

### Article II:

If a defect develops in any of the electrical components for up to twenty-four (24) month from the shipment date, Better Water Industries, Inc. will, at its option, replace, repair, or rebuild the motor according to the

If a defect develops in chlorinator housing or any plastics of the chlorinator for up to sixty (60) months from ship date, Better Water Industries, Inc. will, at its option, replace, or rebuild said defective part according to Article V.

### Article IV:

Section One: Return defective part to Better Water Industries, Inc. postage prepaid

Section Two: Enclose the return tag with a written description of the defect.

Section Three: Also enclose a statement assuring BWI Inc. that the products were properly installed, not misused or abused.

Section Four: Replacement or Credit will be issued after BWI Inc. inspects the unit and concurs on the said defect.

BWI Inc. warrants all replacement parts for ninety (90) days from date of shipment.
